Price action on NYSE carved a structural Chaikin Money Flow Accumulation Node, supported by a volume ratio expansion of 0.62x over the baseline.

RSI momentum registers at 58, defining an expanding overbought envelope. Cross-validation via the EMA-20 confirms strong trend support.
