Longer-horizon AI stock forecasting models estimate the 30-day and 90-day targets at \$1980 and \$2227.9 respectively, maintaining a sentiment alpha profile of -0.32.

Price action on Cboe BZX carved a structural Bollinger Band Squeeze Phase, supported by a volume ratio expansion of 1.38x over the baseline.

With normalized EPS tracking steadily at \$40.04, our valuation models suggest that the company's revenue growth rate of 37.1% is fundamentally supported by robust, high-quality asset turnover cycles.

Quality score evaluation returns an high ranking for EPS metrics (\$40.04), heavily correlated with structural subsidiary spin-off optimization trends.

## SENTIMENT FLOW & MICROSTRUCTURE

Analysis of order book thickness reveals that institutional blocks are quietly building deep support beds, lowering the risk of sudden liquidity shocks before the upcoming earnings date on Jul 13.

Dark pool derivatives activity tracks a 34%% volume migration prior to the upcoming earnings date on Jul 13.
